


Fig.1 Power Dissipation Derating Curve

Fig.3 Single Pulse Maximum Power dissipation






Fig.5 Typical Output Characteristics(II)

Junction Temperature




Fig.9 Forward Transfer Admittance vs.

Drain Current




Fig.10 Drain Current Derating Curve




Fig.11 Static Drain - Source On - State Resistance vs. Gate Source Voltage




Fig.12 Static Drain - Source On - State
Resistance vs. Junction Temperature




Fig.13 Static Drain - Source On - State Resistance vs. Drain Current (I)




Fig.14 Static Drain - Source On - State Resistance vs. Drain Current (II)




Fig.15 Static Drain - Source On - State Resistance vs. Drain Current (III)




Fig.16 Static Drain - Source On - State Resistance vs. Drain Current (IV)

Fig.17 Static Drain - Source On - State Resistance vs. Drain Current (V)




Fig.18 Static Drain - Source On - State
Resistance vs. Drain Current (VI)






Fig.19 Typical Capacitance vs.

Fig.20 Switching Characteristics




Switching Time : t [ns]

Source Drain Voltage






Fig. 1-1 SWITCHING TIME MEASUREMENT CIRCUIT


