




Transconductance




 V_{DS} - Drain-to-Source Voltage (V) $\label{eq:capacitance}$


On-Resistance vs. Drain Current










On-Resistance vs. Junction Temperature



Source-Drain Diode Forward Voltage




Avalanche Current vs. Time


Drain Source Breakdown vs. **Junction Temperature**





Safe Operating Area



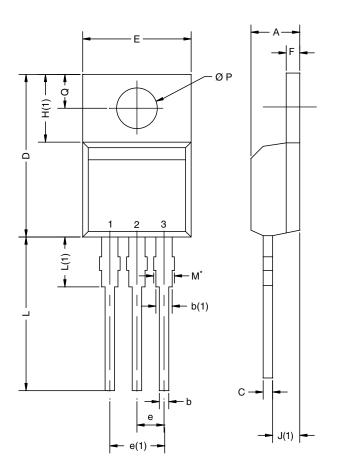

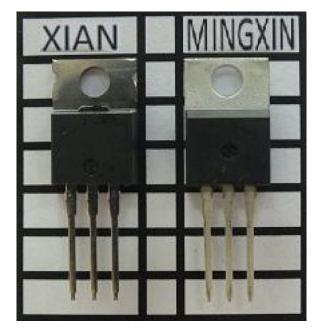
